The Ballarat Foundation works across 4 key pillars to alleviate the cycles of disadvantage in our community. These 4 pillars are:

EARLY CHILDHOOD

Every child enters school ready to learn and with an opportunity to prosper.

We run the Ballarat Reads program, distribute funding through grants and partner with others to ensure that children enter school with appropriate social and emotional skills for their age and literacy and numeracy skills to allow them to prosper.

YOUTH SUCCESS

Every young person has the skills and opportunities to prosper in employment.

We run the L2P Driver Mentor program, distribute funding through grants and partner with others to ensure that the youth in our community have the skill and opportunities to gain meaningful and stable employment.

HOUSING SECURITY

Every child, person or family has the security of a home.

We look to assist with grants and infrastructure, so that no person, child or family goes without the safety of a home.

FOOD SECURITY

Every child, person or family has continuous access to safe and nutritious food.

We distribute funding through grants and assist community groups to deliver food programs so that no family goes without a continuous and safe supply of nutritious food.

The Ballarat Foundation is a catalyst for positive community change by enabling philanthropic solutions to social problems. We promote socially responsible giving, engage donors, build community partnerships, deliver grants and operate programs which reduce disadvantage and encourage connection, cohesion and prosperity.

JOINT REPORT FROM OUR CHAIR AND CEO

On behalf of the Ballarat Foundation, we are extremely proud of our achievements in 2021 amid a difficult and challenging time as the implications of the COVID19 pandemic continued to impact every part of our community.

To name just three headline achievements of 2021, we saw:

- Distributions to community projects and programs which exceeded \$146,000
- A continuing and meaningful response to community needs created by COVID19, including growth in partnerships through program delivery including emergency food relief and homelessness.
- Finalising plans for the creation of a new centre for charities in the Ballarat CBD

These outcomes would not be possible without the work of our operations team and volunteer board members.

We would like to specifically acknowledge our committed and

passionate board and operations team members, including former Volunteering Ballarat program coordinator Jessica Frost-Camillieri.

Conversely, we are proud to welcome Lisa Hall who led the volunteering program implementation in the second half of 2021.

Our work to facilitate better community outcomes through our established L2P, Ballarat Reads and Volunteering Ballarat programs continues.

Through these programs, we have been able to connect more than 3000 individuals and businesses with the Ballarat Foundation and make a difference to our community. Despite the suspension of activity during the imposed periods of restrictions, we continued to engage program participants which ensured a smooth transition as restrictions eased.

Despite the challenges posed by conducting events in a COVIDSafe way, Dancing with our Stars went ahead at the Civic Hall in March, raising more than \$100,000, successfully showcasing the community's continued support for the foundation's work.

While Run for a Cause was again conducted as a "virtual" event, it was a beacon to showcase online engagement and fundraising opportunities which the foundation has been at the forefront of during the past two years. The long-running partnership with the Foundation for Regional and Rural Renewal matched with community donations from the event will allow the foundation to significantly increase distribution of vouchers for families of school-aged children across the region in 2022

While we have continued to look for innovative and new ways to garner community support, there have also been several long-term partners who have continued their very generous support, for which we are very grateful.

Importantly, in 2021, we have been able to translate all this support into direct impact of the causes and organisations we support.

Some of community impact highlights include:

- Finalising plans for the redevelopment of our office - Chatham House – with a view to creating a new centre for charities in the Ballarat CBD

-Continuing to expand sub fund growth in line with the organisational strategy to increase funds distribution to reduce disadvantage in the community

-The gifting of more than \$146,000 in grants to more than 20 community organisations through our various grant programs and sub funds;

-Helping children to build a love of books and reading, with more than 3400 books delivered through our Ballarat Reads program;

-Distributing \$25,000 in vouchers to assist some of our most vulnerable families have what their children need for school;

-50 young drivers graduated through the L2P program, obtaining a licence, with the guiding help of more than 90 volunteer mentors.

-Supporting the volunteering sector through promotion and building capability of more than 50 volunteer agencies.

In 2022, like so many in our community and indeed the world, we face the ongoing challenge of supporting the community and our operations beyond the COVID-19 pandemic. It is clear this crisis will shape the Foundation's role and focus for many years to come.

A very heartfelt thank you to each organisation and individual who is a supporter of the Ballarat Foundation and the work we do – these are relationships even more vital during challenging times.

We look forward to continuing all of these great relationships into the future as we connect people, continue to promote philanthropy in fresh and innovative ways and most importantly build a community that is just, equitable and free of poverty.

TREASURER'S REPORT

The Ballarat Foundation consists of three entities, The Ballarat Foundation United Way Inc, Ballarat Foundation Charitable Fund and Ballarat Foundation Trust. For the purposes of this report these three entities will be referred to as the Ballarat Foundation.

At The Ballarat Foundation we have been fortunate to have the ability to continue to make an impact on the community as the pandemic continued into 2021.

Program income for the year totaled \$843,707 and the sub funds continued to grow with income totaling \$361,661. The overall surplus for the Foundation in 2021 is \$120,748.

Grant distributions totaling \$149,635 from the Ballarat Foundation were paid throughout the year.

The Ballarat Foundation exists to make a positive and lasting difference to the people in the Ballarat region. To achieve this purpose, it is vital that a focus is maintained on growing the corpus, through donations, bequests and investment of sub funds. The corpus is the lifeblood of the Foundation and facilitates the generous annual distributions to be provided.

Because the majority of the funds and sub funds of the Ballarat Foundation are held for perpetuity, the growth in the corpus provides for the long-term meaningful impact for the Ballarat region.

At 2021 year-end, \$4,107,728 of assets is held in the Ballarat Foundation corpus compared to \$3,638,066 in 2020.

With JB Were managing the investment of sub fund monies, the corpus has grown substantially in 2021, enabling the Foundation to continue to work to our objective of alleviating the cycle of disadvantage in our community.

As detailed in the Financial Statements the investments of the Ballarat Foundation are held as property, cash and trade receivables.

Community engagement through our programs and events such as Dancing with our Stars and Run for a Cause has ensured the Foundation can continue as a viable contributor to the Ballarat region.

COMMUNITY IMPACT

EARLY CHILDHOOD

BALLARAT READS

The Ballarat Reads program, in partnership with the Dolly Parton's Imagination Library, delivers high-quality books to children's homes each month from birth to 5 years of age. Research clearly shows that reading to children is a key way

to develop literacy skills and the program enables this by building a home library.

In 2021, a total of 3436 Imagination Library books were mailed out to children in the Ballarat area with 124 new children joining the program and 78 children receiving their graduation book on turning 5 years of age.



BACK TO SCHOOL VOUCHERS

Working through local community organisations, the FRRR Back to School program is a practical, positive program that makes a real difference in the lives of children by providing \$50 gift vouchers from Target to students in need.

The vouchers are redeemable for items such as school uniforms, clothing, shoes, school bags and stationery items necessary to engage and participate at school. The program is funded by various trusts, foundations and individuals who generously provide the financial backing for the program.

The Ballarat Foundation has been working with FRRR since 2005 to deliver the Back to School program and in 2021 there were 400 vouchers distributed to families across 43 primary schools in the Ballarat region.

YOUTH SUCCESS

L2P LEARNER DRIVER MENTOR PROGRAM

A driver's licence is essential for the independence that young people need to enable them to access employment, further training and social activities. Many young people lack the support networks to get the driving experience they require. For others there may be insufficient finances or limited access to a vehicle.

The TAC L2P Learner Driver Mentor Program (L2P program) matches disadvantaged learner drivers between the ages of 16–21 years with experienced volunteer mentor drivers. These mentors help the learners gain the 120 hours, of driving experience required prior to gaining their probationary licence.

Ballarat Foundation has secured funding from TAC/ Department of Transport until June 2023, to continue this important program.

Currently, seven cars are in use for driving sessions, which enabled 250 learners in 2020/2021 (delayed due to Covid) to gain their licence. Experience for learners comes from practice drives with their mentor, along with professional driving lessons. Volunteers are trained through VicRoads. All mentors must complete appropriate checks and have a satisfactory driving history. This program not only assists young people in gaining their licence, it also helps with them gain employment, independence, confidence and increases their social engagement.

SORAYA'S STORY

Soraya started in the program early 2021 in the middle of the lockdowns. Being 22, Soraya was desperate to get support to learn driving. She has no adult support all through her life as her father passed when she was young, and mother never been in the picture. Support workers and wellbeing coordinators at school were the only support access for herself and her 3 siblings. Soraya was matched with one of our experienced mentors, Wayne. She said it was never easy to manage things on her own without the adult support, but we were lucky enough to be guided in the right direction. Soraya was a quick learner when it comes to driving, doing a traineeship at VicRoads, however it was with the available public transport to get to and from trainings and to manage other appointments for herself and her siblings. As a passionate and dedicated mentor Wayne offered Soraya his free time when they were allowed to be on the roads amid lockdowns. They developed a great partnership and Wayne was glad to help Soraya knowing her circumstances and her commitment to get her family to the next stage of life. Now, as an independent driver, Soraya secured a full time job after her traineeship and she said that having a driver's licence listed in her resume helped greatly in securing the job she enjoys visiting her sister who lives 300 km away which she could see her first time in two and half years. Also, she said it is the sense of freedom and not needing to rely on others to take her other siblings to appointments and able to go out at any time of the day without checking the bus schedule and missing the appointments because of missing buses. Soraya is confident that she will participate in the program as a mentor in the next 3 years once she gains her full licence...what a fantastic outcome! We appreciate her community mindedness and wish her success!



YOUTH STRATEGY

The Ballarat Foundation Youth Leadership Collective (YLC) was formed on the back of a Youth Leadership forum early in 2021. The need for an ongoing Youth Leadership group was identified. Twelve young people from six different schools applied and thus the YLC was born. Each week the group of shy, but enthusiastic VCAL students came together to learn, discuss, advocate and develop skills relating to personal development and leadership. Some of the highlighted activities included, public speaking, presentations to local member for parliament, Michaela Settle and to the Ballarat Foundation Board of Directors. Students participated in a tyre changing workshop and learned how to form a budget. Several the activities focussed on teambuilding skills such as scavenger hunts, escape rooms, student led lessons and fun mini challenges. The students impressively all rose to each occasion and demonstrated excellent growth and development both individually and as a group. Some of the youth identified key goals that the students were working towards finding a solution included;

- Advocating for changes greater accessibility to public transport and importantly the ability to top up Myki via iPhone, this was changed at State Government level - an exciting outcome for the group's advocacy.
- Reducing food insecurity in secondary schools, the amazing outcome for this goal was the purchase and delivery of food items and equipment provided to schools to support breakfast programs to the value of \$10,000.
- The final goal was increasing training and development accessibility for young people, the young people explored options for training and development, partook in some informal training and designed their own training program.

The young people agreed that that YLC was enjoyable and valuable and that they will miss being part of the YLC. They enjoyed meeting new friends, learning skills and being involved in a very practical group.

Some comments from the group members include:

“YLC has been the best part of my week, I like coming to meet with everyone and I think my confidence has improved,”

“It was hard online, but it was still fun”

“The best part was hearing Kaleb’s speech, so funny”

“I never thought I would be able to talk in front of people, I was always way too anxious and now I just made a speech to a politician.”

The YLC members showed great resilience and adaptability and were able to change from face-face sessions to online when needed, due to lockdowns. Members are going on to pursue participation in Youth Parliament, further leadership programs, TAFE scholarships and employment opportunities post the completion of the YLC. We wish them well with their endeavours and look forward to hearing of their success as individuals and as community leaders in the future.

It’s wonderful to see when given an opportunity, young people can and do, really step up and show their potential. What an amazing group of leaders.

HOUSING SECURITY

HOMELESSNESS FORUM

In November 2021, Ballarat Foundation teamed up with members from the Ballarat Future Shapers (previously LBWR) to facilitate a homelessness forum. Key leaders in homelessness services, business and community organisations came together to tackle the complex issues surrounding homelessness.

The extent of the housing crisis was made clear with lived experiences stories and homelessness support worker challenges being shared during the forum. Attendees contributed through discussion, to finding possible solutions whether it be outreach vehicles, driving lessons for those over 23 years old or viable housing options to assist in reducing homelessness across the region.

As a result of this forum, Ballarat Foundation has established a Housing Support sub fund that will provide financial assistance to agencies that directly support vulnerable people who find themselves in a position where they do not have stable or suitable, ongoing accommodation. We look forward to 2022 and the growth of this fund to provide much needed support in this area.

RUN FOR A CAUSE

Due to COVID restrictions, our 2021 Run for a Cause was a virtual event.

Participants were asked to become local heroes, raising funds to help us reach our target of raising \$50,000 which would allow the Ballarat Foundation to deliver 1000 Back to School Vouchers to local families doing it tough.

Local heroes could sign up and set their own activity challenge for the month of November which would be counted towards the community goal of 50,000km.

The virtual challenge boasted around 150 participants running and walking their way around Ballarat to raise funds for the Back to School Voucher

Program.

With the support of our major sponsor, Federation University, our community impact partner, Heinz Law, generous donations from the community and grants from The Foundation for Rural & Regional Renewal, we were able to raise a total of \$54,524 equating to 1,080 vouchers for local families doing it tough.

DANCING WITH OUR STARS

Dancing with our Stars saw ten well-known and much-loved local identities battle it out on the dance floor for the glittering crown and bragging right to be named the Dancing with our Stars Champion.

Each Star was asked to secure a sponsor and was given a target of \$5,000 to raise over the course of four months. Through a total of 16 fundraising events and initiatives, \$104,184 was raised by our stars during the course of the project.

The event is made possible by the generosity of Shelley Ross, the owner of the Dance Studio in Ballarat, who donates hundreds of hours to teach our Stars how to dance. Each Star was paired with an experienced dancer, was given a style of dance, and was then provided with three or more lessons each week for ten weeks.

The culmination of all of the fundraising, rehearsals and dance lessons were celebrated on Saturday 20 March at the gala event. The event boasted 170 guests and was also live streamed across Australia to 190 watch parties.
