### The role of directors

In preparation for the end of term of the current Chair and Deputy Chair in May 2025, the foundation is seeking candidates with previous experience in leadership roles at not-for-profit, philanthropic and corporation boards and/or operations.

As a Director, you will be motivated, well organised and community-orientated. You will drive the company's strategic direction, goals and objectives to influence the future direction of the organisation. And you will be passionate about the Ballarat community. Your role as director is to provide advice and direction on strategic matters and to represent the foundation within your networks and our community.



### The role of directors

Directors will be appointed for an initial three-year term. Under the rules of incorporation, directors can serve a maximum of three terms (total 9 years).

#### What is the time commitment?

Board meetings occur six times a year. Directors are also asked to participate in sub-committees and working groups. The meeting schedules for these groups vary. As a director you can expect to commit four-six hours per month, increasing for office bearer roles.

Director roles are not remunerated.
